Emergency Market Surcharge (EMS)

Most trade lanes are facing significant space constraints, and carriers are dedicating a rising share of their allocations to premium rate bookings. Long-term, named account bookings are more and more restricted, and container availability continues to be a challenge.

As a result of these general market conditions and to better ensure your supply chain continuity, your equipment availability, and your bookings, CEVA Logistics has decided to implement an **Emergency Market Surcharge (EMS)** as part of our Ocean Freight rate structure. CEVA is continuously monitoring the market situation and will provide further information and updates when available. This **EMS** is subject to regular reviews, and your rates will remain aligned to market conditions.
